Net Metering Update

Two proposals at the Public Service Commission of Wisconsin will make investing in rooftop solar harder and more expensive by making significant changes to "net metering." Net metering is a utility billing policy that enables customers who generate electricity from their own solar systems to receive a bill credit for any energy they export to the grid. According to Solar Energy Industries Association (SEIA), "traditional net energy metering (NEM) is fundamentally a bill credit that represents the full retail value of distributed electricity delivered to the distribution system and has been a critical policy for valuing and enabling distributed generation." This arrangement encourages residential and business customers to invest in solar power, reducing carbon emissions and providing substantial economic benefits to their neighbors and communities.

Wisconsin Power and Light (Alliant) proposes a drastic overhaul to net metering with a complicated set of charges and credits that are subject to change. Madison Gas and Electric (MGE) proposes to eliminate net metering altogether.

SOLAR EVENTS AND GRANT OPPORTUNITIES

The U.S. Environmental Protection Agency (EPA) \$7 billion Solar for All grant competition is now open for applications! The competition will fund projects that increase access to residential solar energy for households in low-income and disadvantaged communities, helping to cut home energy bills and provide families with resilient and secure power.

To compete in this competition, all applicants are required to submit a Notice of Intent (NOI) by the following deadlines:

- July 31, 2023, for states, DC, and PR;
- August 14, 2023, for territories, municipalities, and eligible nonprofit recipients; or
- August 28, 2023, for Tribal governments and Intertribal Consortia. Applications are due on September 26, 2023!

The **Couillard Solar Foundation** will be co-hosting a 'Sustain All Around Dane County' event with **Sustain Dane** in Deerfield WI on Aug 24th.

From the Environmental Law & Policy Center (ELPC):

In response to the national movement to protect mature and old-growth forests, the Biden administration opened an Advanced Notice of Proposed Rulemaking to invite suggestions on how the US Forest Service should respond.

The national campaign sought to submit 500,000 comments in support of a permanent rule protecting mature and old-growth forests from logging on USFS and BLM lands. This is very important in Wisconsin where the Chequamegon-Nicolet National Forest continues to log mature stands in defiance of President Biden's conservation policies.

The comment period closed on July 20, 2023, with over half a million people from every age group and corner of the country calling for a lasting, durable rule that would protect mature and old-growth trees and forests from logging as a cornerstone of U.S. climate policy.
